- Post-Election Campaign Finance Report: Must be filed after the election, but no later than 4:00 p.m. on November 21, 2017.
- Subsequent Campaign Finance Report(s): July 1, 2018 and every July 1 thereafter by 4:00 p.m. until the campaign has a zero balance.
