Questions received by June 17, 2020:

1. Is there a bidders list/plan holders list available?

There is no bidders list/ plan holder list available for the project.

2. Will the contractor be responsible to submit the as-built certification by licensed PE or PS for the SWM facility, or will the City be responsible for that?

The contractor is required to provide the as-built survey of the completed SWM facility in CAD format and provide the necessary supporting documentation including material tickets and third-party inspection. Our contracted engineering firm will prepare the red lines and submit to DPIE for as-built approval.

3. Is this a wage scale project?

No, the project does not have this requirement.

4. Is there a minority subcontractor requirement?

No, the project does not have this requirement.

5. Is there a pre-bid meeting?

There is no pre-bid meeting for the project. An appointment can be scheduled for a site visit.

6. Is a bid bond required for the project?

No bid bond is required for the project. A performance bond will be required within 10 days of contract execution.

7. Is the project subject to Davis Bacon wage rates?

No, the project does not have this requirement.

8. Do you anticipate extending the bid due date?

12. Confirm the quantity of Victor Stanley benches – specification sheet (323300-3) calls for 8 but plan page LS-101 identifies 11. Please confirm the quantity.

There is only one stabilized construction entrance for the project.

14. Provide specs for the for the agility equipment.

There is information about the agility equipment on sheet LS-502

15. Provide better detail/layout of the agility equipment

The general note #2 on sheet LS-502 provides information related to the layout of these pieces, which will be coordinated with the project officer and landscape architect.

16. Provide clarification on LS-101 – the notes show what a bench looks like and then is numbered in the notes as 7 but on the drawing it is marked 17 which is MDSHA Standard No. MD374.65. the legends also have things identified that are not identified in the drawing. Interpreting the furniture layout and storm drains and deciphering what is what is difficult because some pages say an item is one thing and then another page says it is another thing.
