This set of worksheets may be used to prepare and submit four of the Campaign Finance Reports required by the City Code. Their use is not required. The "paper report" forms that are part of your packet may also be used.

You are responsible for the accuracy of these documents. These spreadsheets are for your convenience, double-check your work.

Fill in the campaign information requested in the **Campaign Info Worksheet**. Include any balance you may have from a previous campaign. The info will be entered in the following spreadsheets as appropriate.

There are thirteen (13) other spreadsheets in this Workbook. Three for each report. They are linked together so that once you enter dollar value information in "Initial Contributions and Expenditures" it will appear in the subsequent reports as well.

The individual sheets can be seen\selected by using the "tabs" at the bottom of the sheets. Use the left\right arrows to reveal those tabs that are probably hidden from your view. They are arranged from left to right in the order of the report due date.

Enter dates as 10/2/19 or 10/02/19. Excel will format the date automatically after you go to the next field.

Balances will be automatically carried forward from the Initial Report to the Pre-Election Report to the Post Election Report to the Subsequent Report. You will not be able to enter anything into the Balance Forward field in any of the sheets except the "Initial Contribution" sheet. Use it if you have funds from a previous campaign.

You will find that you cannot enter data into any of the "totals". These should automatically total your entries on the sheet and in the case of the summary sheets, duplicate entries from other sheets. If you need to make a change in these protected fields, something is wrong, and you should review what you are doing. If something still appears to be wrong contact the BOES.

Remember -Election Reports can be filed electronically only if they have been pre-authorized. If they are mailed they must be mailed in time to be received by the deadline, not post-marked on the deadline day. Regular mail is not a reliable means to ensure a specific delivery date. If faxed to meet the filing deadline, a paper copy must be received by 4 PM the next business day.
